

Privacy and Security Policy

CST Brands LLC, CrossAmerica Partners LLP and their affiliates (collectively, "CST Brands" or "Company" or "We") have created this Privacy and Security Policy (the "Policy") in order to demonstrate our company's commitment to privacy and security of visitors to the CST Brands websites and other related or linked CST Brands websites (the "Site"). The Policy should be read in conjunction with the Company's [Legal Notice & Terms of Use](#). Due to the sensitive nature of the information we collect from visitors, which may include, your name, mailing address, phone numbers, email address and credit card information ("Personally Identifiable Information"), we believe it is important to satisfy strict privacy requirements. The following discloses our information gathering and dissemination practices for the Site and how we handle information we learn about you from your visit to the Site. The information that we receive and use depends on what you do when you visit the Site.

IP Address

When your web browser or e-mail application requests a web page or e-mail from another computer on the Internet, it automatically gives that computer the address where it should send the information. This is called your computer's "IP address." (IP stands for "Internet protocol.") For most users accessing the Internet from a dial-up Internet service provider (ISP), the IP address will be different every time you log on. We use your IP address to help diagnose service or technology problems with our server, and to administer the Site. We use your IP address to send you the most appropriate advertising based on geographic area or information derived from your IP address. Many IP addresses are commonly associated with Internet service providers, universities, or major corporations in specific regions or localities. Aggregate information derived from IP addresses may also be reported to advertisers. Your IP address is used to help identify you, to track activity within the Site and to gather broad demographic information which is used to further develop advertisements, products and services.

Cookies

A cookie is a small amount of data, which often includes an anonymous unique identifier, that is sent to your browser from a web site's computers and stored on your computer's hard drive. The Site uses cookies to keep track of your session ID. We may use cookies to deliver content specific to your interests or to track specific data that needs to be available on multiple web pages. Cookies are necessary for the system to work properly. Any cookie in use by our web server is temporary and will be removed when the user logs out or is timed-out by the server. Our server contains links to other related web sites. We do not control or have access to the information that is collected or used on those sites, via cookie or otherwise. You can configure your browser to accept all cookies, reject all cookies, or notify you when a cookie is set. (Each browser is different, so check the "Help" menu of your browser to learn how to change your cookie preferences.) If you reject all cookies, you will not be able to use our products or services that require you to "sign in," and you may not be able to take full advantage of all offerings.

Consumer Information/Information Collection

When you browse the Site and have not registered for any online service from CST Brands, you browse anonymously. Personally Identifiable Information is not collected as you browse rather only upon direct submission by you.

When you submit information to this Site (including, but not limited to, completing retail employment applications, information requests and registering for email alerts or webcasts), you may be asked to provide Personally Identifiable Information. For instance, in the employment application and on the various "contacts" and registration pages, we may ask for this Personally Identifiable Information in order to facilitate requests, provide personalized service and communicate separately with a visitor. These direct submissions of information, which may or may not include Personally Identifiable Information, may be gathered by CST Brands in furtherance of the uses listed above.

CST Brands does, however, use "cookies" to collect non-personal information about how the Site is used. Non-personal information, such as the server your computer is logged onto, your browser type, and whether you responded to a CST Brands banner ad or e-mail is collected and tracked. This non-personal information is used for analytical purposes, such as measuring response rates to banner ads and e-mail offers.

Other Nonpublic Personal Information

When you submit your information for a credit card application, CST Brands retrieves a credit report. CST Brands may also generate and store a consumer credit score and personalized recommendations for each registered user. Some registered users may also receive pre-approved offers of credit while at the Site. Registered users may request CST Brands to retrieve and generate this credit-related information multiple times in a year at no cost to you. The credit report is typically stored for approximately 45 days. The scores, recommendations and any offers viewed or accepted and the dates of that information may be stored indefinitely. While these items are not sold to third parties for any reason, they may be used to qualify registered

users for certain products, services or promotions. See the Disclosure of Personal Information section below for additional information.

Disclosure of Personal Information

We do not sell, trade or rent any Personally Identifiable Information collected from this Site with any nonaffiliated third parties. However, from time to time, we may enter into contractual agreements with nonaffiliated third parties to provide services. These parties may receive your Personally Identifiable Information in the following limited circumstances:

(a) To contractors and third parties we use to support our business (such as fulfillment services, Web hosting facilities or technical support), in which case we will require such third parties to agree to treat your information in accordance with this Privacy Policy and use it only for the same purposes;

(b) In connection with the sale, assignment or other transfer of all or a portion of the business of CST Brands, in which case we will require any such buyer to agree to treat your information in accordance with this Policy and use it only for the same purposes;

(c) To respond to valid legal process and law enforcement requests or, where required by applicable laws, court orders or government regulations;

(d) To protect and defend our rights and property, including misuse or unauthorized use of the Site; or

(e) To protect the personal safety or property of our users or the public (among other things, this means that if you provide false information or attempt to pose as someone else, information about you may be disclosed as part of any investigation into your actions).

Advertising and Promotions

While at the Site, we may use information you provide to inform you of products and services offered by CST Brands and third parties, as well as advertisements and promotions for products and services offered at other web sites or retail establishments. If you click on an ad or promotion which appears on our site without accepting an offer for a product or service, we will not provide individually identifiable data to the third party offering the ad or promotion. Overall demographic information may be shared with these advertisers on an aggregate basis, without individually identifiable information.

Acceptance of Offers

If you accept products or services offered by third parties while remaining on the Site, Personally Identifiable Information required for such acceptance, such as name, address and social security number, provided to us will be transmitted to the third party only upon final acceptance of that product or service. Customers will be informed that they are accepting a product or service of a third party, and may or may not be subsequently linked to the third party's web site. Third party suppliers might include providers of financial services, credit information, or other consumer products, and may have privacy policies related to their web site, the internet and e-commerce which are different than ours. If you do not want your individually identifiable information shared with any third parties, do not accept any offers for services from third party organizations. Prior to any such acceptance you will be informed that some or all of your individually identifiable and nonpublic information may likely be shared with that organization. CST Brands may make other disclosures as permitted or required by law to nonaffiliated third parties in addition to those described in the notice.

Prospect Information

This Site encourages registered users to send e-mail messages to us and to provide us with e-mail and name information for friends who may be interested in the services and information provided at the Site. We provide the registered user with an e-mail hyperlink to refer friends to the Site. That information is stored in a prospect database and is listed as a referral from the registered user for up to 90 days. This information is not sold or distributed to any third parties.

Web Site Links

The Site contains links to other sites. CST Brands is not responsible for the privacy practices or the content of such websites. Please refer to those sites for specific information about their privacy or security practices or policies.

Changes to the Privacy and Security Policy

The protection of consumer information is one of the guiding principles behind CST Brands. Because of that stance, registered users will be notified via e-mail (if you have provided us with your e-mail address) of any changes to the Privacy and Security Policy. We will also post a change notification marker on www.cstbrands.com home page for review.

Security

This Site has security measures in place to protect against the negligent or inadvertent loss, misuse and alteration of the information under our control. CST Brands' networking systems include an industry standard firewall and systems that are both physically and logically protected (via secured locations and passwords). Consumer information will be regularly backed-up and stored in a secure location. Credit Report information will be kept on our servers in encrypted format for a maximum of 45 days. Other consumer data (such as name, address, etc.) will be kept on an industry standard computer database fully protected behind a firewall.

Supplementation Information

This Site supplements the information you provide us with information that is received from third parties, such as credit bureaus and census data.

Notice to Parents and Children Under 13 Years Old

CST Brands is committed to protecting children's privacy and we encourage parents and guardians to take an active role in their children's online activities and interests. We do not knowingly collect Personally Identifiable Information from children under the age of 13 and we do not target the Site to children less than 13 years of age. We therefore also ask if you are under 13 years old, please do not provide CST Brands any of your Personally Identifiable Information (for example, your name, address and email address). If you are under 13 years old and you nevertheless wish to ask a question or use the Site in any way that requires you to submit any such Personally Identifiable Information please get your parent or guardian to do so on your behalf. If we learn we have collected or received Personally Identifiable Information from a child under 13 without verification of parental or guardian consent, we will delete that information.
